MEALS: The Marconi Conference Center, located just out of Marshall, CA is a property of the CA State Parks System. Their 24-hour "booking clock" starts with Check-In at 3 PM on the opening day, followed by dinner, lodging, breakfast, and lunch the next day. Then the 24hour "booking clock" begins again. Therefore, the MEETING PACKAGE will be a 48-hour period from 3 PM on Wednesday through the field tour lunch on Friday. Departure on the Tour at 9:30 AM on Friday will necessitate prior Check-Out from your lodging. Daily admission will not include any lodging as noted above in the registration form.

LODGING: The Marconi Conference Center offers lodging, meals and meeting facilities as an inclusive package. It encompasses 62 wooded acres overlooking Tomales Bay. The CALPAC Section – SRM has pre-purchased lodging and meals for 60 guests for two days and roommate assignments will be made at the time of registration. Once the site of Guglielmo Marconi's trans-Pacific wireless station (1913-1920), today's Marconi Conference Center offers contemporary accommodations, tasty meals and professional meeting facilities in a unique setting. The 62-acre California State Historic Park overlooks Tomales Bay, 48 miles northwest of San Francisco on the spectacular Marin Coast.

The Marconi Conference Center & State Historic Park has a rich human history that dates back thousands of years. From the pre-historic villages of the Coastal Miwok to the farming communities of today, the Tomales Bay ecosystem has supported the livelihoods of thousands of people. The 2005 Fall Meeting of the Cal-Pac Section - Society of Range Management will take the history of Tomales Bay and move it forward, exploring the management opportunities and constraints in these working landscapes.
